LEAP's theme throughout the year, as exemplified at our Great Expectations gala, has been the Power of Partnerships. Our ability to live up to our values, meet our goals and serve almost 600 uniquely talented students is largely possible because of our partners, donors and volunteers.

Accordingly, LEAP made volunteerism, partnerships and collective impact key pillars of our new FY 2025-2027 Strategic Plan. We have invested resources to strengthen our capacity to recruit and manage volunteers and partners by:

- Creating the full-time position of Volunteer and Partnerships Coordinator; and,
- Working towards Service Enterprise Certification awarded by the Mass Service Alliance to organizations with volunteer best practices.

In FY2024, we collaborated with eight business partners and welcomed 169 volunteers who worked over 3,000 hours during the year to provide student academic, post-secondary and career services, as well as work on data projects, events and fundraising, strategic planning and board service.

Our FY2025-FY2027 Strategic Plan (See Strategic Plan overview on opposite page) is an inclusive effort involving over 100 stakeholder interviews and surveys. This plan will drive student and organizational success through focused investments in people, programs and partners.

Other accomplishments in FY2024:

- Served 577 unique students, with average attendance rates of 85%
- A post-secondary enrollment rate of 90% and post-secondary graduation rate of 90% for those who continued with our postsecondary advising for their first year
- 100% of students completed and 93% presented their projects in our Summer Work Program, which employed 97 students, each working one-on-one with a volunteer career mentor
- Named one of six national finalists for excellence in summer learning from the National Summer Learning Association for our unique middle school summer program operated in partnership with Lynn Public Schools

LEAP staff, board members and students are so grateful for your belief in our mission and your continued support and volunteerism as we and our partners continue building LEAP to serve more students and families in our community.



Alumnus Profile: Kevin Melo

Kevin Melo has been a part of LEAP for more than half his life. He arrived in Salem from the DR with his mother when he was eleven years old. At the time, LEAP was still known as "CyberSpace," and attending CyberSpace changed his life. Kevin made friends and learned English, practicing with his friends. CyberSpace was also his go-to place for homework help.

Kevin fell in love with computers at LEAP. "I'd racethrough my homework," he said, "so I could have more time on the computer." As a participant in the College Success Program (now College and Career Pathways Program), Kevin realized how influential learning about computing was, and with the guidance of his advisor, began to think about the kind of post-secondary education he would need to pursue a career in computing. He credits LEAP staff with enabling him to think through his choices so that by the time he reached Salem State he did not have to pick a "placeholder major" as he calls it, but instead knew he was taking the first steps to reach his career goal by majoring in computer science.

In his senior year Kevin was offered a paid internship at start-up DataOne Software, located in the Cummings Center. After graduation, he was offered a full-time position, and he remains at DataOne five years later having been promoted to Software Developer II. Kevin believes that LEAP has had a "profound effect" on his life and that exposed him to things and ideas he never would have thought about. At LEAP he also "met good people" and says that other young students today will find that is still true. "LEAP helps a lot of students who don't have anyone," Kevin concludes, "LEAP was my everyone."

ACADEMIC ENRICHMENT: Students learn in a variety of settings that broaden their academic knowledge. Project-based, experiential learning helps students see the connections between academics and career paths and develop 21st century skills such as problem solving, critical thinking, and collaboration.

Students participate in education and career development lessons and workshops to help them chart a course for their future. Students identify their strengths and interests and connect them to educational pathways and careers with ongoing support from advisors.








Financials 7/1/23 - 6/30/24


